### **Public Comments:**

Reminder that the Mother's Day Art Fair will be held May 13 and 14. Volunteers are needed to help, and a sign-up sheet was passed. Presale tickets for the quilt were offered for sale.

A complaint was raised citing overbilling for sanitation services on the tax bill. Kevin advised the complainant to contact Graham Hoad (Sunset Beach Sanitary District).

An alert was made by community members citing gasoline siphoning in the area of 7<sup>th</sup>-10<sup>th</sup> Streets on the greenbelt parking. Police are alerted and are aware.

# **Guest Speakers:**

Orange County Supervisor, Andrew Do, explained the role and responsibilities of the supervisors. He shared his involvement in establishing mental health and homeless facilities/shelters for the County. His responsibilities include voting on budgets: the budget total goes to the state for approval; the state decides how much each county receives; the Board of Supervisors then decide how the money will be spent. This year's budget was 9 billion dollars.

A portion of the current Supervisor budget of 9 billion dollars will provide for supportive housing; sand replenishment; law enforcement criticisms; rebuilding John Wayne Airport; 405 expansion, streetcar light rail system in Santa Ana; and BeWell Mobile Response.

The Supervisors support cities financially to build out support facilities in their communities, e.g. homeless facilities (shelters).

An informational community coffee will be held May 31, 2023 at 5:30 pm at Ocean View Adult School.

June 1, 2023 a meeting will be held at the Nobles Family Community Center regarding beach sand replenishment.

Also in attendance with Supervisor Do was the Director of Community Engagement.
